HEREBY RESOLVES

Article 1. To approve the anticipated contracts and transactions in 2026 between VietCredit General Finance Joint Stock Company (the Company) and related parties in accordance with Article 70 of the Law on Credit Institutions, Article 167 of the Law on Enterprises and Article 45 of the Company's Charter, including:

- 3) To approve the anticipated contracts and transactions between the Company and related persons of the other Internal actors of the Company (excluding related persons of managers and related persons of members of the Supervisory Board) in 2026 under the authority of the BOD as stipulated in the Company's Charter.
