The actual result of remuneration and allowances in 2025 for members of the Board of Directors (BOD) and the Board of Supervisors is VND 4,312,978,478
- Details of remuneration and allowances for members of the Board of Directors (BOD) and the Board of Supervisors in 2025 are presented in detail in the 2025 Audited Financial Statements.

- Authorize the Board of Supervisors to decide on remuneration, bonuses (if any) and other benefits for each member of the Board of Supervisors according to the resolution of the 2026 General Meeting of Shareholders.
